With Pre-Authorized Debit, you can manage how you want to pay your taxes on your terms. You can make monthly payments or pay the full amount every May and September. No more keeping track of payment dates, writing post-dated cheques or looking for a postage stamp.

The payments will come out the last day of the month, or the first business day of the proceeding month if the last day falls on a weekend or holiday.
